

Explicit homotopy limits of dg-categories and twisted complexes

Abstract

In this paper we study the homotopy limits of cosimplicial diagrams of dg-categories. We first give an explicit construction of the totalization of such a diagram and then show that the totalization agrees with the homotopy limit in the following two cases: (1) the complexes of sheaves of \mathcal{O} -modules on the Čech nerve of an open cover of a ringed space (X, \mathcal{O}) ; (2) the complexes of sheaves on the simplicial nerve of a discrete group G acting on a space. The explicit models we obtain in this way are twisted complexes as well as their D -module and G -equivariant versions. As an application we show that there is a stack of twisted perfect complexes.

1 Introduction

Homotopy limits in a model category are an important way to present descent data. In this paper we consider homotopy limits in $\mathrm{dgCat}_{\mathrm{DK}}$, the category of (small) dg-categories with the Dwyer-Kan model structure [Tab05b].

The homotopy limit of some diagrams in $\mathrm{dgCat}_{\mathrm{DK}}$ can be explicitly constructed. For example in [BBB13] Section 4 the *homotopy fibre product* $B \times_D^h C$ of the diagram

$$\begin{array}{ccc} & B & \\ & \downarrow c & \\ C & \xrightarrow{d} & D \end{array}$$

is given using the *path object* in $\mathrm{dgCat}_{\mathrm{DK}}$ constructed in [Tab10]. In [BBB13] the authors use this construction to further prove the Milnor descent of cohesive dg-categories.

Higher dimensional analogues of the path object are given by *simplicial resolutions* in $\mathrm{dgCat}_{\mathrm{DK}}$ which were constructed in ([Hol14]). They can be used to explicitly compute arbitrary homotopy limits and we will use them to take homotopy limits over cosimplicial diagrams.

In algebra and geometry it is often interesting to consider the homotopy limit of a cosimplicial diagram in dgCat . For example, let $\mathcal{U} = \{U_i\}$ be an open cover of a ringed space (X, \mathcal{O}) and the functor

$$Cpx : \mathrm{Space}^{op} \rightarrow \mathrm{dgCat}$$

be the contravariant functor which assigns to each ringed space U the dg-category of complexes of \mathcal{O}_U -modules on U . Then we have a cosimplicial diagram in $\mathrm{dgCat}_{\mathrm{DK}}$

$$\coprod Cpx(U_i) \rightrightarrows \coprod Cpx(U_i \cap U_j) \rightrightarrows \coprod Cpx(U_i \cap U_j \cap U_k) \cdots \quad (1)$$

Intuitively the homotopy limit of Diagram 1 is given by gluing data and higher gluing data and in this paper we give a precise construction: the homotopy limit is given by the dg-category of *twisted complexes*, see Section 4.3 for details.

We deduce from this characterization that the presheaf of twisted perfect complexes is in fact a stack.

Remark 1.1. In [TT78] Toledo and Tong first introduced twisted complexes as a tool to glue the characteristic classes of coherent sheaves on complex manifolds. Implicitly they have shown that twisted complexes present the descent data of complexes of sheaves. However, as far as we know, the fact that twisted complexes are the homotopy limit of Diagram (1) has never been explicitly stated and proved in the literature. This is the main reason for us to write the current paper.

Remark 1.2. We will also consider variations of this question where the cover is not given by open subsets of X and Cpx is only a pseudo-functor instead of a functor and hence the diagram corresponding to Diagram (1) is not a strict cosimplicial diagram. We resolve this problem by rectification, see Section 4.1 for details.

The strategy of our construction is that we first construct the *totalization* of the cosimplicial diagram and then show that the homotopy limit and totalization are weakly equivalent in good cases. Actually many interesting cosimplicial diagrams in $dgCat$ fall into these "good cases", see Section 4.3 and Section 4.6 for details.

The paper is organized as follows: In Section 2 we review the Reedy model structure and the homotopy limit of a cosimplicial diagram in a general model category.

In Section 3 we focus on dg-categories. In Section 3.1 we review the simplicial resolution of a dg-category. In Section 3.2 we give the construction of the totalization and homotopy limit of a cosimplicial diagram in $dgCat_{DK}$.

In Section 4 we use these results to study twisted complexes. In particular, in Section 4.1 we construct a rectification of the diagrams associated with pseudo-functors. In Section 4.2 we give a criterion for when the totalization is weakly equivalent to the homotopy limit. In Section 4.3 we study the homotopy limit of Diagram 1, i.e. complexes of sheaves on the Čech nerve of an open cover, and show this is equivalent to the category of twisted complexes. In Section 4.4 we study the homotopy limit of strict perfect complexes with respect to open covers. In Section 4.5 we construct a presheaf of twisted perfect complexes and show that it is in fact a stack. In Section 4.6 we study the complexes of sheaves on the simplicial space associated to a group acting on a space.

2 A review of homotopy limits in a model category

2.1 A quick review of the Reedy model structure

In this subsection we give a quick review of Reedy model structure. For more details see [Hir03] Chapter 15 or [Rie14] Chapter 14.

Definition 2.1. [[Hir03] Definition 15.1.2] A *Reedy category* is a (small) category \mathcal{C} equipped with two subcategories $\overrightarrow{\mathcal{C}}$ (the direct category) and $\overleftarrow{\mathcal{C}}$ (the inverse category), both of which contain all the objects of \mathcal{C} , in which every object can be assigned a nonnegative integer (called the degree) such that

1. Every non-identity morphism of $\overrightarrow{\mathcal{C}}$ raises degree.
2. Every non-identity morphism of $\overleftarrow{\mathcal{C}}$ lowers degree.
3. Every morphism g in \mathcal{C} has a unique factorization $g = \overrightarrow{g} \overleftarrow{g}$ where \overrightarrow{g} is in $\overrightarrow{\mathcal{C}}$ and \overleftarrow{g} is in $\overleftarrow{\mathcal{C}}$.

We need the concepts of latching and matching categories as follows.

Definition 2.2. [[Hir03] Definition 15.2.3] Let \mathcal{C} be a Reedy category and let α be an object of \mathcal{C} . The *latching category* $\partial(\overrightarrow{\mathcal{C}} \downarrow \alpha)$ of \mathcal{C} at α is the full subcategory of the overcategory $(\overrightarrow{\mathcal{C}} \downarrow \alpha)$ containing all the objects except the identity map of α . The *matching category* is defined dually.

Now let \mathcal{C} be a Reedy category and \mathcal{M} a category closed under limits and colimits. We consider the category $\mathcal{M}^{\mathcal{C}}$ of \mathcal{C} -diagrams in \mathcal{M} .

Definition 2.3. [[Hir03] Definition 15.2.5] Let \mathcal{C} be a Reedy category and \mathcal{M} a category closed under limits and colimits. Let \mathcal{X} be a \mathcal{C} -diagram in \mathcal{M} , i.e. \mathcal{X} is a functor $\mathcal{C} \rightarrow \mathcal{M}$. Let α be an object of \mathcal{C} . The *latching object* of \mathcal{X} at α is $L_{\alpha}\mathcal{X} = \operatorname{colim}_{\partial(\mathcal{C}\downarrow\alpha)} \mathcal{X}$ and the latching map of \mathcal{X} at α is the natural map $L_{\alpha}\mathcal{X} \rightarrow \mathcal{X}_{\alpha}$. The *matching object* $M_{\alpha}\mathcal{X}$ is defined dually.

Let \mathcal{X} and \mathcal{Y} be \mathcal{C} -diagrams in \mathcal{M} and $f : \mathcal{X} \rightarrow \mathcal{Y}$ be a map of \mathcal{C} -diagrams. It is clear that f induces maps between latching and matching objects $f : L_{\alpha}\mathcal{X} \rightarrow L_{\alpha}\mathcal{Y}$ and $f : M_{\alpha}\mathcal{X} \rightarrow M_{\alpha}\mathcal{Y}$. Moreover we can define the following maps.

Definition 2.4. [[Hir03] Definition 15.3.2] Let \mathcal{C} be a Reedy category and \mathcal{M} a category closed under limits and colimits. Let $f : \mathcal{X} \rightarrow \mathcal{Y}$ be a map of \mathcal{C} -diagrams. Let α be an object of \mathcal{C} . The *relative latching map* of f at α is the map $\mathcal{X}_{\alpha} \amalg_{L_{\alpha}\mathcal{X}} L_{\alpha}\mathcal{Y} \rightarrow \mathcal{Y}_{\alpha}$. The *relative matching map* is defined dually.

Definition 2.5. [[Hir03] Definition 15.3.3] Let \mathcal{C} be a Reedy category and \mathcal{M} a model category. Let $f : \mathcal{X} \rightarrow \mathcal{Y}$ be a map of \mathcal{C} -diagrams, then

1. f is a *Reedy weak equivalence* if for every object α of \mathcal{C} , the map $f_{\alpha} : \mathcal{X}_{\alpha} \rightarrow \mathcal{Y}_{\alpha}$ is a weak equivalence in \mathcal{M} .
2. f is a *Reedy cofibration* if for every object α of \mathcal{C} , the relative latching map $\mathcal{X}_{\alpha} \amalg_{L_{\alpha}\mathcal{X}} L_{\alpha}\mathcal{Y} \rightarrow \mathcal{Y}_{\alpha}$ is a cofibration in \mathcal{M} .
3. f is a *Reedy fibration* if for every object α of \mathcal{C} , the relative matching map $\mathcal{X}_{\alpha} \rightarrow \mathcal{Y}_{\alpha} \times_{M_{\alpha}\mathcal{Y}} M_{\alpha}\mathcal{X}$ is a fibration in \mathcal{M} .

This defines a model structure on $\mathcal{M}^{\mathcal{C}}$, called the *Reedy model category structure*.

In particular, a \mathcal{C} -diagram \mathcal{X} is Reedy fibrant if for every object α of \mathcal{C} , the matching map $\mathcal{X}_{\alpha} \rightarrow M_{\alpha}\mathcal{X}$ is a fibration in \mathcal{M} .

2.2 A review of homotopy limits of general Reedy diagrams in a model category

In this subsection we review the construction of homotopy limit in a model category. For more details see [Hir03] Chapter 18 and 19.

Let \mathcal{C} be a small category, then for any object c of \mathcal{C} we can consider the overcategory $(\mathcal{C} \downarrow c)$ and its nerve $N(\mathcal{C} \downarrow c)$. Moreover a morphism $\sigma : c \rightarrow c'$ in \mathcal{C} induces a functor $\sigma_* : (\mathcal{C} \downarrow c) \rightarrow (\mathcal{C} \downarrow c')$ and hence a map between simplicial sets $N(\sigma_*) : N(\mathcal{C} \downarrow c) \rightarrow N(\mathcal{C} \downarrow c')$. In conclusion $N(\mathcal{C} \downarrow -)$ gives a \mathcal{C} -diagram of simplicial sets.

Now we consider a model category \mathcal{M} and let \mathcal{X} be a \mathcal{C} -diagram in \mathcal{M} . We want to explicitly construct the homotopy limit $\operatorname{holim} \mathcal{X}$. First we introduce the following definition.

Definition 2.6 ([Hir03] Definition 16.6.1). Let X be an object in a model category \mathcal{M} . A *simplicial frame* on X is a simplicial object \widehat{X} in \mathcal{M} together with a weak equivalence $cs_* X \rightarrow \widehat{X}$ in the Reedy model category structure on $\mathcal{M}^{\Delta^{op}}$ such that

1. the induced map $X \rightarrow \widehat{X}_0$ is an isomorphism;
2. if X is a fibrant object of \mathcal{M} , then \widehat{X} is a fibrant object in the Reedy model category $\mathcal{M}^{\Delta^{op}}$.

If $\mathcal{Y} = Y_{\bullet}$ is a simplicial object in \mathcal{M} and K is a simplicial set, then we can naturally define the mapping object \mathcal{Y}^K . It is clear that the construction is functorial in both \mathcal{Y} and K .

Now we can give the formula of homotopy limits.

Definition 2.7 ([Hir03] Definition 19.1.5). Let \mathcal{M} be a framed model category and \mathcal{C} be a small category. If \mathcal{X} is a \mathcal{C} -diagram in \mathcal{M} , then the *homotopy limit* $\operatorname{holim}(\mathcal{X})$ of \mathcal{X} is defined to be the equalizer of the maps

$$\prod_{c \in \operatorname{Ob}(\mathcal{C})} (\widehat{X}_c)^{N(\mathcal{C}\downarrow c)} \begin{array}{c} \xrightarrow{\phi} \\ \xrightarrow{\psi} \end{array} \prod_{(\sigma: c \rightarrow c') \in \operatorname{Mor}(\mathcal{C})} (\widehat{X}_{c'})^{N(\mathcal{C}\downarrow c)} \quad (2)$$

where \widehat{X}_c is the natural simplicial frame on X_c and $N(\mathcal{C} \downarrow c)$ is the nerve of the over category $\mathcal{C} \downarrow c$. The projection of the map ϕ on the factor $\sigma : c \rightarrow c'$ is the composition of a natural projection from the product with the map

$$\sigma_*^{id_{N(\mathcal{C} \downarrow c)}} : (\widehat{X}_c)^{N(\mathcal{C} \downarrow c)} \rightarrow (\widehat{X}_{c'})^{N(\mathcal{C} \downarrow c)}$$

and the projection of the map ψ on the factor $\sigma : c \rightarrow c'$ is the composition of a natural projection from the product with the map

$$(id_{\widehat{X}_{c'}})^{N(\sigma_*)} : (\widehat{X}_{c'})^{N(\mathcal{C} \downarrow c')} \rightarrow (\widehat{X}_{c'})^{N(\mathcal{C} \downarrow c)}.$$

2.3 Homotopy limit and the totalization of a cosimplicial object

In this subsection we take \mathcal{C} to be the cosimplicial index category Δ . In this case a Δ -diagram in \mathcal{M} is exactly a cosimplicial object in \mathcal{M} . Let $\mathcal{X} = \{X^\bullet\}$ be such a cosimplicial object. By Definition 2.7 the homotopy limit of \mathcal{X} has the following form

$$\prod_{[n] \in Ob(\Delta)} (X^n)^{N(\Delta \downarrow [n])} \begin{array}{c} \xrightarrow{\phi} \\ \xrightarrow{\psi} \end{array} \prod_{(\sigma : [n] \rightarrow [m])} (X^m)^{N(\Delta \downarrow [n])}. \quad (3)$$

Although it is possible to compute the homotopy limit by Equation (3), we have a problem that the simplicial set $N(\Delta \downarrow [n])$ is too big. Hence we are looking for an alternative formula of the homotopy limit.

Definition 2.8 ([Hir03] Definition 18.6.3 and 19.8.1 or [Rie14] Example 4.3.1). Let $\mathcal{X} = \{X^\bullet\}$ be a cosimplicial object in a framed model category \mathcal{M} . The *totalization* of \mathcal{X} $Tot(\mathcal{X})$ is the equalizer of the maps

$$\prod_{[n] \in Ob(\Delta)} (X^n)^{\Delta[n]} \begin{array}{c} \xrightarrow{\phi} \\ \xrightarrow{\psi} \end{array} \prod_{(\sigma : [n] \rightarrow [m])} (X^m)^{\Delta[n]} \quad (4)$$

where the projection of the map ϕ on the factor $\sigma : [n] \rightarrow [m]$ is the composition of the natural projection from the product with the map $\Delta_n(\sigma_*) : (X^n)^{\Delta[n]} \rightarrow (X^m)^{\Delta[n]}$ and the projection of the map ψ on the factor $\sigma : [n] \rightarrow [m]$ is the composition of the natural projection from the product with the map $\sigma^*(X^m) : (X^m)^{\Delta[m]} \rightarrow (X^m)^{\Delta[n]}$.

We want to seek relations between totalization and homotopy limit. For Reedy fibrant cosimplicial objects we have the following theorem.

Theorem 1. *Let $\mathcal{X} = \{X^\bullet\}$ be a Reedy fibrant cosimplicial object in a framed model category \mathcal{M} . Then $Tot(\mathcal{X})$ is naturally weakly equivalent to $holim(\mathcal{X})$.*

Proof. [Hir03] Theorem 19.8.4. □

Remark 2.1. In fact in the original statement of [Hir03] Theorem 19.8.4 there is no requirement of Reedy fibrancy. However it seems to be a typo.

Theorem 1 tells us that in good cases we can use the totalization to compute the homotopy limit, which will dramatically simplify the computation.

3 The homotopy limits of cosimplicial objects in $dgCat_{DK}$

In this section we take \mathcal{M} to be the $dgCat_{DK}$, i.e. the category of (small) dg-categories equipped with the Dwyer-Kan model structure [Tab05b].

Definition 3.1. Let $dgCat$ be the category of small dg-categories. There is a model structure on $dgCat$, called the *Dwyer-Kan (DK) model structure*, where a dg-functor $F : \mathcal{B} \rightarrow \mathcal{C}$ is

- a weak equivalence if
 1. for all objects $x, y \in \mathcal{B}$, the component $F_{x,y} : \mathcal{B}(x, y) \rightarrow \mathcal{C}(F(x), F(y))$ is a quasi-isomorphism of complexes;
 2. the induced functor $H^0(F) : H^0(\mathcal{B}) \rightarrow H^0(\mathcal{C})$ is an equivalence of categories.

- a fibration if

1. for all objects $x, y \in \mathcal{B}$, the component $F_{x,y}$ is a degreewise surjection;
2. for each morphism $\theta : F(x) \rightarrow z$ which is invertible in $H^0(\mathcal{C})$, it could be lifted to an morphism $\tilde{\theta}$ which is invertible in $H^0(\mathcal{B})$.

We denote dgCat with the Dwyer-Kan model structure by dgCat_{DK} .

We will give an explicit construction of the totalization and homotopy limit of a cosimplicial object in dgCat_{DK} .

Remark 3.1. There is another model structure on dgCat introduced in [Tab05a] called the *Morita model structure*. This is the left Bousfield localization of the DK model structure along functors which induce equivalences on the derived categories. Here the derived category of a dg-category \mathcal{D} is the category of functors from the opposite of \mathcal{D} to chain complexes, localized at objectwise quasi-isomorphisms.

It is important to note that any computation of homotopy limits in the DK model structure also allows the computation of homotopy limits in the Morita model structure, see [Hol15a] Lemma 1.

3.1 The simplicial resolution in the category of dg-categories

In this subsection we discuss the simplicial resolution in the category of dg-categories, which is introduced in [Hol14]. First we introduce some notations and definitions.

Let \mathcal{B} be a (small) dg-category and S be a (fixed) set of index and $\mathcal{E} = \{E_i | i \in S\}$ and $\mathcal{F} = \{F_i | i \in S\}$ be two collections of objects of \mathcal{B} . We define

$$C^p(\mathcal{B}, \text{Hom}^q(\mathcal{E}, \mathcal{F})) = \prod_{|I|=p+1, I=\{i_0 \dots i_p\}} \text{Hom}_{\mathcal{B}}^q(E_{i_p}, F_{i_0}). \quad (5)$$

For an index set $I = \{i_0, \dots, i_p\}$ (the i_j 's may be repeated), an element $\phi_I^{p,q} = \phi_{i_0 \dots i_p}^{p,q}$ of $C^p(\mathcal{B}, \text{Hom}^q(\mathcal{E}, \mathcal{F}))$ is an element in $\text{Hom}_{\mathcal{B}}^q(E_{i_p}, F_{i_0})$. Here we call p the simplicial degree of ϕ , call q the \mathcal{B} degree of ϕ and call $|\phi| = p + q$ the total degree of ϕ .

Definition 3.2. The differential on $\phi \in \prod_{p+q=k} C^p(\mathcal{B}, \text{Hom}^q(\mathcal{E}, \mathcal{F}))$ is defined by the following formula.

$$(\mathbf{D}\phi)_{i_0 \dots i_p}^{p,q+1} := (-1)^p d_{\mathcal{B}}(\phi_{i_0 \dots i_p}^{p,q}) + \sum_{j=1}^{p-1} (-1)^j \phi_{i_0 \dots \widehat{i_j} \dots i_p}^{p-1, q+1}. \quad (6)$$

It is easy to check that $\mathbf{D} \circ \mathbf{D} = 0$.

Moreover, we define the *shuffled multiplication* of two elements $\phi \in C^p(\mathcal{B}, \text{Hom}^q(\mathcal{F}, \mathcal{G}))$ and $\eta \in C^r(\mathcal{B}, \text{Hom}^s(\mathcal{E}, \mathcal{F}))$ as

$$(\phi \cdot \eta)_{i_0 \dots i_{p+r}}^{p+r, q+s} = (-1)^{qr} \phi_{i_0 \dots i_p}^{p,q} \circ \eta_{i_p \dots i_{p+r}}^{r,s} \quad (7)$$

From now on the notation " \cdot " will be preserved for the shuffled multiplication.

We can also check that the differential and multiplication satisfy the Leibniz rule, i.e.

$$\mathbf{D}(\phi \cdot \eta) = (\mathbf{D}\phi) \cdot \eta + (-1)^{|\phi|} \phi \cdot (\mathbf{D}\eta).$$

Definition 3.3. [See [Hol14] Definition 3.2] Let \mathcal{B} be a (small) dg-category. Then $\Delta_n(\mathcal{B})$ is a dg-category with objects given by pairs (\mathcal{E}, ϕ) where \mathcal{E} is a collection E_0, E_1, \dots, E_n of objects in \mathcal{B} and ϕ is a collection $\phi_I^{k, 1-k} \in \text{Hom}_{\mathcal{B}}^{1-k}(E_{i_k}, E_{i_0})$ for all multi-indices $I = (i_0, \dots, i_k)$, $0 \leq i_0 \leq \dots \leq i_k \leq n$. These pairs must satisfy the Maurer-Cartan equation

$$\mathbf{D}\phi + \phi \cdot \phi = 0. \quad (8)$$

More precisely, for any $I = \{i_0 \dots i_k\}$, we have

$$(-1)^k d_{\mathcal{B}}(\phi_{i_0 \dots i_k}^{k, 1-k}) + \sum_{j=1}^{k-1} (-1)^j \phi_{i_0 \dots \widehat{i_j} \dots i_k}^{k-1, 2-k} + \sum_{j=1}^{k-1} (-1)^{(1-j)(k-j)} \phi_{i_0 \dots i_j}^{j, 1-j} \circ \phi_{i_j \dots i_k}^{k-j, 1-k+j} = 0. \quad (9)$$

Moreover we require that all $\phi_{ij}^{1,0} \in \text{Hom}_{\mathcal{B}}^0(E_i, E_j)$ (including $\phi_{ii}^{1,0}$) are homotopically invertible and in particular $\phi_{ii}^{1,0} = id$. On the other hand we require all $\phi_{i_0 \dots i_k}^{k,1-k}$'s equal to 0 if they have repeated indices and $k \geq 2$.

Morphisms from (\mathcal{E}, ϕ) to (\mathcal{F}, ψ) are given as follows.

$$\text{Hom}_{\Delta_n(\mathcal{B})}^m((\mathcal{E}, \phi), (\mathcal{F}, \psi)) = \prod_k \prod_{\substack{(i_0 \dots i_k) \\ 0 \leq i_0 \leq \dots \leq i_k \leq n}} \text{Hom}_{\mathcal{B}}^{m-k}(E_{i_k}, F_{i_0})$$

and the differential d on a degree m morphism θ is given by

$$d\theta = D\theta + \psi \cdot \theta - (-1)^m \theta \cdot \phi. \quad (10)$$

Remark 3.2. Definition 3.3 differs from the simplicial resolution in [Hol14] in the sense that in Definition 3.3 we allow the $\phi^{k,1-k}$'s with repeated subscripts, while the simplicial resolution in [Hol14] requires strictly increasing subscripts. However, we demand that for $k \geq 2$, all $\phi^{k,1-k}$'s with repeated subscripts are 0, thus the two definition are given by exactly the same data. The differential also agrees. Moreover, in Definition 3.3 we also make the \pm sign coincide with those in [OTT81b]

Example 3.1. An object in $\Delta_1(\mathcal{B})$ consists of two object E_0 and E_1 of \mathcal{B} , a degree 0 morphism $\phi_{01}^{1,0} : E_0 \rightarrow E_1$ which is invertible in the homotopy category together with the $\phi_{00}^{1,0}$ and $\phi_{11}^{1,0}$.

A degree m morphism from (\mathcal{E}, ϕ) to (\mathcal{F}, ψ) is given by a collection of morphisms $\theta_0^{0,m}, \theta_1^{0,m}, \theta_{01}^{1,m-1}$ and the degenerate ones $\theta_{00}^{1,m-1}$ etc. The differential on θ is given by Equation (10). In particular the differential of the non-degenerate θ 's is given by

$$D(\theta_0^{0,m}, \theta_1^{0,m}, \theta_{01}^{1,m-1}) = (d\theta_0^{0,m}, d\theta_1^{0,m}, d\theta_{01}^{1,m-1} + \psi_{01}^{1,0} \theta_1^{0,m} - (-1)^m \theta_0^{0,m} \phi_{01}^{1,0})$$

Remark 3.3. The non-degenerate part of $\Delta_1(\mathcal{B})$ agrees with the path object $P(\mathcal{B})$ as constructed in [Tab10] Section 3. The only differences is that we include two morphisms $\phi_{00}^{1,0}$ and $\phi_{11}^{1,0}$.

Definition 3.4. For any map $\sigma : [n] \rightarrow [m]$ in the simplicial category $\mathbf{\Delta}$, we can define the induced map $\sigma^* : \Delta_m(\mathcal{B}) \rightarrow \Delta_n(\mathcal{B})$. Actually for an object $(\mathcal{E} = \{E_0, \dots, E_m\}, \phi)$ of $\Delta_m(\mathcal{B})$, we define

$$\sigma_*(\mathcal{E}) = \{E_{\sigma(0)}, \dots, E_{\sigma(n)}\}$$

and

$$(\sigma_*(\phi))_{i_0 \dots i_k}^{k,1-k} = \phi_{\sigma(i_0) \dots \sigma(i_k)}^{k,1-k}.$$

σ_* of morphisms are defined similarly.

Therefore $\Delta_{\bullet}(\mathcal{B})$ is a cosimplicial object in dgCat . In [Hol14] it has been proved that $\Delta_{\bullet}(\mathcal{B})$ has the following properties.

Proposition 1 ([Hol14] Proposition 3.9). *The inclusion from the constant simplicial dg-category $c\mathcal{B}$ to $\Delta_{\bullet}(\mathcal{B})$ is a levelwise weak equivalence.*

Proof. See [Hol14] Proposition 3.9. □

The next important property of $\Delta_{\bullet}(\mathcal{B})$ is the Reedy fibrancy.

Proposition 2 ([Hol14] Proposition 3.10). *The simplicial dg-category $\Delta_{\bullet}(\mathcal{B})$ is Reedy fibrant.*

Proof. See [Hol14] Proposition 3.10. □

Corollary 1. *For a dg-category \mathcal{B} , the simplicial resolution $\Delta_{\bullet}(\mathcal{B})$ in Definition 3.3 give a simplicial frame of \mathcal{B} in dgCat_{DK} .*

Proof. It is a direct corollary of Definition 2.6, Proposition 1 and Proposition 2. □

Remark 3.4. A related concept is the category $dga_{\geq 0}$ consisting of dg-algebras of nonnegative degree and there is a projective model structure on $dga_{\geq 0}$ such that the inclusion $dga_{\geq 0} \hookrightarrow dgCat$ preserves the model structure. For any dg-algebra B of nonnegative degree there is a simplicial resolution of B given by $\Omega_{\text{poly}}(\Delta^\bullet) \otimes B$, where $\Omega_{\text{poly}}(\Delta^n)$ is the ag-algebra of the polynomial differential forms on the geometric simplex Δ^n .

However, for a dg-category \mathcal{B} , $\Omega_{\text{poly}}(\Delta^\bullet) \otimes \mathcal{B}$ in general is not Reedy fibrant hence does not give a simplicial resolution. In fact the natural dg-functor $p : \Omega_{\text{poly}}(\Delta^1) \otimes \mathcal{B} \rightarrow \Omega_{\text{poly}}(\partial\Delta^1) \otimes \mathcal{B} = \mathcal{B} \times \mathcal{B}$ is not a fibration. In fact let $\theta : x \xrightarrow{\sim} y$ be an isomorphism up to homotopy between two different objects in \mathcal{B} , then $(\theta, id) : (x, x) \xrightarrow{\sim} (y, x)$ is an isomorphism up to homotopy in $\mathcal{B} \times \mathcal{B}$ but (θ, id) cannot be in the image of p because all objects in the image of p are of the form (x, x) .

The following result follows from the definitions:

Proposition 3. $\Delta_n(\mathcal{B})$ is a model for the mapping dg-category $\mathcal{B}^{\Delta[n]}$.

3.2 The totalization and homotopy limit of cosimplicial dg-categories

Let $\{\mathcal{B}^\bullet\}$ be a cosimplicial object in $dgCat_{\text{DK}}$. We first study its totalization $\text{Tot}(\mathcal{B}^\bullet)$. Definition 2.8 tells us that $\text{Tot}(\mathcal{B}^\bullet)$ is the equalizer of

$$\prod_{[n] \in \text{Ob}(\Delta)} \Delta_n(\mathcal{B}^n) \begin{array}{c} \xrightarrow{\phi} \\ \xrightarrow{\psi} \end{array} \prod_{(\sigma: [n] \rightarrow [m]) \in \text{Mor}(\Delta)} \Delta_n(\mathcal{B}^m).$$

hence it is a subcategory of $\prod_{[n] \in \text{Ob}(\Delta)} \Delta_n(\mathcal{B}^n)$. Let $\prod_n(\mathcal{E}^n, \phi^n)$ be an object in $\text{Tot}(\mathcal{B}^\bullet)$ where each (\mathcal{E}^n, ϕ^n) is an object in $\Delta_n(\mathcal{B}^n)$. Recall that \mathcal{E}^n consists of a collection of object $\{E_0^n, \dots, E_n^n\}$ in \mathcal{B}^n . The basic idea of the construction is to get rid of the redundant data. First we have the following proposition.

Proposition 4. Let $\prod_n(\mathcal{E}^n, \phi^n)$ be an object in $\text{Tot}(\mathcal{B}^\bullet)$. For each n let $d_i^n : [0] \rightarrow [n]$ be the map that sends 0 to i , then for each n and i we have

$$E_i^n = d_i^n(E_0^0).$$

In other words, each \mathcal{E}^n is determined by $\mathcal{E}^0 = \{E_0^0\}$.

Proof. Recall that $\text{Tot}(\mathcal{B}^\bullet)$ is the equalizer of

$$\prod_{[n] \in \text{Ob}(\Delta)} \Delta_n(\mathcal{B}^n) \begin{array}{c} \xrightarrow{\phi} \\ \xrightarrow{\psi} \end{array} \prod_{(\sigma: [n] \rightarrow [m]) \in \text{Mor}(\Delta)} \Delta_n(\mathcal{B}^m).$$

Now pick $\sigma = d_i^n : [0] \rightarrow [n]$ we get

$$\begin{array}{ccc} \Delta_0(\mathcal{B}^0) & & \\ & \searrow_{\Delta_0((d_i^n)_*)} & \\ & & \Delta_0(\mathcal{B}^n) \\ & \nearrow_{(d_i^n)^*(\mathcal{B}^n)} & \\ \Delta_n(\mathcal{B}^n) & & \end{array}$$

Recall by Definition 3.4 we have $(d_i^n)^*\mathcal{E}^n = \{E_i^n\}$. Therefore $\prod_n(\mathcal{E}^n, \phi^n)$ belongs to its equalizer implies that $E_i^n = d_i^n(E_0^0)$. \square

Now we move on to study the ϕ^n 's in $\text{Tot}(\mathcal{B}^\bullet)$. First we need the following observation.

Lemma 1. Let $I = (i_0, \dots, i_k)$, $0 \leq i_0 \leq \dots \leq i_k \leq n$ be a multi-index. Then there exists a unique order-preserving map

$$\sigma : [k] \rightarrow [n]$$

such that $\sigma(j) = i_j$ for all $0 \leq j \leq k$.

Proof. It is self-evident. \square

Definition 3.5. For any $k \geq 1$ we call the morphism $\phi_{01\dots k}^{k, 1-k}$ in \mathcal{B}^k the k th standard morphism.

Proposition 5. Let $\prod_n(\mathcal{E}^n, \phi^n)$ be an object in $\text{Tot}(\mathcal{B}^\bullet)$. Let $I = (i_0, \dots, i_k)$, $0 \leq i_0 \leq \dots \leq i_k \leq n$ be a multi-index and $\phi_{i_0 \dots i_k}^{k, 1-k}$ be the corresponding morphism in \mathcal{B}^n . Let $\phi_{01 \dots k}^{k, 1-k}$ be the k th standard morphism in \mathcal{B}^k and $\sigma : [k] \rightarrow [n]$ be the map as in Lemma 1. Then we have

$$\phi_{i_0 \dots i_k}^{k, 1-k} = \sigma_*(\phi_{01 \dots k}^{k, 1-k}) \in \text{Hom}_{\mathcal{B}^n}^{1-k}(d_{i_k}^n(E_0^0), d_{i_0}^n(E_0^0)).$$

In other words, each morphism is determined by the standard morphisms.

Proof. The proof is very similar to that of Proposition 4 and is left as an exercise. \square

From now on, when we talk about a morphism $\phi_{i_0 \dots i_k}^{k, 1-k}$, we always think it as $\sigma_*(\phi_{01 \dots k}^{k, 1-k})$.

Theorem 2. Let $\{\mathcal{B}^\bullet\}$ be a cosimplicial object in dgCat_{DK} . An object of $\text{Tot}(\mathcal{B}^\bullet)$ consists of a pair (E, ϕ) where E is an object in \mathcal{B}^0 and ϕ is a collection of standard morphisms

$$\phi_{0 \dots k}^{k, 1-k} \in \text{Hom}_{\mathcal{B}^k}^{1-k}(d_k^k(E), d_0^k(E))$$

which satisfy the following two conditions

1. the Maurer-Cartan equation

$$D\phi + \phi \cdot \phi = 0 \tag{11}$$

or more explicitly

$$(-1)^k d_{\mathcal{B}}(\phi_{0 \dots k}^{k, 1-k}) + \sum_{j=1}^{k-1} (-1)^j \phi_{0 \dots \hat{j} \dots k}^{k-1, 2-k} + \sum_{j=1}^{k-1} (-1)^{(1-j)(k-j)} \phi_{0 \dots j}^{j, 1-j} \circ \phi_{j \dots k}^{k-j, 1-k+j} = 0. \tag{12}$$

2. $\phi_{01}^{1,0}$ is invertible in the homotopy category $\text{Ho}(\mathcal{B}^1)$.

A degree m morphism θ from (E, ϕ) to (F, ψ) consists of a collection of morphism

$$\theta_{0 \dots k}^{k, m-k} \in \text{Hom}_{\mathcal{B}^k}^{m-k}(d_k^k(E), d_0^k(F)), \text{ for all } k \geq 0$$

and the differential on θ is given by

$$d\theta = D\theta + \psi \cdot \theta - (-1)^m \theta \cdot \phi. \tag{13}$$

Proof. It is consequence of Definition 2.8, Proposition 4 and Proposition 5. \square

Corollary 2. Let $\{\mathcal{B}^\bullet\}$ be a Reedy fibrant cosimplicial object in dgCat_{DK} . Then the construction in Theorem 2 gives an explicit formula of the homotopy limit of $\{\mathcal{B}^\bullet\}$.

Proof. It is a direct corollary of Theorem 1 and Theorem 2. \square

4 Twisted complexes

4.1 Rectification

Let \mathcal{S} be a class of ringed spaces and \mathcal{F} be a functor from \mathcal{S}^{op} to dgCat .

Example 4.1. We can take \mathcal{S} to be the category of schemes over a field k with $\text{char}(k) = 0$ and for any k -scheme X , $\mathcal{F}(X)$ is the dg-category of complexes of \mathcal{O}_X -modules on X .

Now let X_\bullet be a simplicial object in \mathcal{S} , then $\mathcal{F}(X_\bullet)$ becomes a cosimplicial object in dgCat . Then we can apply Corollary 2 to this case.

Now we have a problem: dgCat is a 2-category (See [Tam07]) and in general $\mathcal{F} : \mathcal{S}^{op} \rightarrow \text{dgCat}$ is only a pseudo-functor hence $\mathcal{F}(X_\bullet)$ is a pseudo-cosimplicial object in dgCat . For example when $\mathcal{F} = \text{Cpx}$, for any morphisms $f : X \rightarrow Y$ and $g : Y \rightarrow Z$ between schemes, we have $f^* : \text{Cpx}(Y) \rightarrow \text{Cpx}(X)$ and $g^* : \text{Cpx}(Z) \rightarrow \text{Cpx}(Y)$. However we do not have

$$f^* g^* = (gf)^*$$

because they are only canonically isomorphic. See [Vis05] Section 3.2.1.

We have this problem in Section 4.6, and thus we need to find a canonical rectification of the diagram. The construction is as follows. First we have the following definition inspired by [Vis05] Definition 3.10.

Definition 4.1. A dg pseudo-functor \mathcal{F} on \mathcal{S} consists of the following data

1. For each object X of \mathcal{S} a dg-category $\mathcal{F}(X)$;
2. For each morphism $f : X \rightarrow Y$ a dg-functor $f^* : \mathcal{F}(Y) \rightarrow \mathcal{F}(X)$;
3. For each object X of \mathcal{S} a (strict) isomorphism $\epsilon_X : id_X^* \xrightarrow{\cong} id_{\mathcal{F}(X)}$ in the dg-category $\text{Fun}(\mathcal{F}(X), \mathcal{F}(X))$;
4. For each pair of arrows $X \xrightarrow{f} Y \xrightarrow{g} Z$ a (strict) isomorphism

$$\alpha_{f,g} : f^* g^* \xrightarrow{\cong} (gf)^* \text{ in } \text{Fun}(\mathcal{F}(Z), \mathcal{F}(X)).$$

These data are required to satisfy the following conditions.

- a. If $f : X \rightarrow Y$ is a morphism in \mathcal{S} and η is an object in $\mathcal{F}(Y)$, then we have

$$\alpha_{id_X, f}(\eta) = \epsilon_X(f^*\eta) \text{ in } \text{Hom}_{\mathcal{F}(X)}(id_X^* f^*\eta, f^*\eta)$$

and

$$\alpha_{f, id_Y}(\eta) = f^* \epsilon_Y(\eta) \text{ in } \text{Hom}_{\mathcal{F}(Y)}(f^* id_Y^* \eta, f^*\eta).$$

- b. For any morphisms $X \xrightarrow{f} Y \xrightarrow{g} Z \xrightarrow{h} W$ and an object θ in $\mathcal{F}(W)$, the diagram

$$\begin{array}{ccc} f^* g^* h^* \theta & \xrightarrow{\alpha_{f,g}(h^* \theta)} & (gf)^* h^* \theta \\ \downarrow f^* \alpha_{g,h}(\theta) & & \downarrow \alpha_{gf,h}(\theta) \\ f^*(hg)^* \theta & \xrightarrow{\alpha_{f,hg}(\theta)} & (hgf)^* \theta \end{array}$$

strictly commutes.

Remark 4.1. Notice that in Definition 4.1 we require that all isomorphisms are strict and all diagrams strictly commute, i.e. not just up to chain homotopy. One could consider more general $(\infty, 1)$ -functors from \mathcal{S} to dg-Cat considered as an $(\infty, 1)$ -category. However we use this definition because on the one hand it simplifies the construction and on the other hand the pseudo-functors we are considering below, like Cpx and $Perf$, fit into Definition 4.1.

Now we will describe how to rectify this pseudo-functor to obtain a diagram. First we consider \mathcal{F} as a dg-category fibered over \mathcal{S} . For a fixed X in \mathcal{S} , the forgetful functor $\mathcal{S}/X \rightarrow \mathcal{S}$ makes \mathcal{S}/X a fibered category over \mathcal{S} and we can consider it as a fibered dg-category over \mathcal{S} . Then we define

$$\tilde{\mathcal{F}}(X) = \text{Fun}_{\mathcal{S}}(\mathcal{S}/X, \mathcal{F}) \tag{14}$$

where the right hand side is the dg-category of dg-functors fibered over \mathcal{S} between \mathcal{S}/X and \mathcal{F} . In more details, a dg-functor $\xi : \mathcal{S}/X \rightarrow \mathcal{F}$ fibered over \mathcal{S} sends each $h : Y \rightarrow X$ in \mathcal{S}/X to an object $\xi(h)$ of the dg-category $\mathcal{F}(Y)$ and each morphism in \mathcal{S}/X

$$\begin{array}{ccc} Y & \xrightarrow{g} & Z \\ & \searrow & \swarrow \\ & X & \end{array}$$

to a degree 0 closed morphism $\xi_g : \xi(Y) \rightarrow f^* \xi(Z)$ in $\mathcal{F}(Y)$ which is further strictly invertible.

Moreover any morphism $f : X \rightarrow Y$ gives a morphism of fibered categories

$$\begin{array}{ccc} \mathcal{S}/X & \xrightarrow{\mathcal{S}/f} & \mathcal{S}/Y \\ & \searrow & \swarrow \\ & \mathcal{S} & \end{array}$$

and hence the composition induces a dg-functor

$$\widetilde{f}^* : \widetilde{\mathcal{F}}(Y) \rightarrow \widetilde{\mathcal{F}}(X).$$

For $\widetilde{\mathcal{F}}$ we have the following lemma.

Lemma 2. $\widetilde{\mathcal{F}} : \mathcal{S}^{op} \rightarrow dgCat$ is a strict functor.

Proof. It is obvious from the definition of \widetilde{f}^* . □

In general $\widetilde{\mathcal{F}}(X)$ is a much larger dg-category than $\mathcal{F}(X)$. Nevertheless we have the following important result.

Proposition 6 (Dg-categorical Yoneda Lemma). *For each X there is a natural equivalence of categories realised by a dg-functor*

$$\Phi : \widetilde{\mathcal{F}}(X) \xrightarrow{\sim} \mathcal{F}(X).$$

In fact Φ is essentially surjective on objects and degreewise fully faithful on morphisms. (In particular Φ is a DK equivalence.)

Proof. The proof is essentially the same as that of [Vis05] 3.6.2 and we give it here for completeness.

For any object ξ in $\widetilde{\mathcal{F}}(X)$ we define $\Phi(\xi)$ to be $\xi(id_X) \in \mathcal{F}(X)$. For each natural transformation $T : \xi \rightarrow \eta$ we define $\Phi(T)$ to be the morphism $T_{id_X} : \xi(id_X) \rightarrow \eta(id_X)$. It is clear that $\Phi : \widetilde{\mathcal{F}}(X) \xrightarrow{\sim} \mathcal{F}(X)$ so defined is a dg-functor.

Then we need to show that Φ is essentially surjective and degreewise fully faithful. For the surjectivity, consider an arbitrary object $E \in \mathcal{F}(X)$, we want to construct a \mathcal{S} -dg-functor $\xi : \mathcal{S}/X \rightarrow \mathcal{F}$ such that $\xi(id_X) = E$. The functor ξ is defined as follows. Given an object $h : Y \rightarrow X$ in \mathcal{S}/X we define $\xi(h) = h^*E$. For a morphism

$$\begin{array}{ccc} Y & \xrightarrow{g} & Z \\ & \searrow h & \swarrow f \\ & & X \end{array}$$

in \mathcal{S}/X we know that there is a natural isomorphism $\alpha_{f,g} : g^*f^* \xrightarrow{\sim} h^*$ hence for E we get

$$\alpha_{f,g}(E) : g^*f^*E \rightarrow h^*E.$$

whose inverse $\alpha_{f,g}^{-1}(E) : h^*E \rightarrow g^*f^*E$ gives $\xi(g) : \xi(h) \rightarrow \xi(f)$. This proves the surjectivity on objects. Notice that $\alpha_{f,g}$ is strictly invertible so we do not need to choose a homotopic inverse of it.

As for the fully-faithfulness, for any natural transformation $T : \xi \rightarrow \eta$ and any $f : Y \rightarrow X$ we consider the diagram

$$\begin{array}{ccc} Y & \xrightarrow{f} & X \\ & \searrow f & \swarrow id_X \\ & & X \end{array}$$

The functoriality of T gives the following commutative diagram

$$\begin{array}{ccc} \xi(f) & \xrightarrow{T_f} & \eta(f) \\ \downarrow \xi_f & & \downarrow \eta_f \\ f^*\xi(id_X) & \xrightarrow{f^*T_{id_X}} & f^*\eta(id_X) \end{array}$$

By definition we know that the vertical arrows ξ_f and η_f are strictly invertible hence for any $f : Y \rightarrow X$, T_f is uniquely determined by T_{id_X} through the formula

$$T_f = (\eta_f)^{-1}f^*T_{id_X}\xi_f.$$

This proves the fully-faithfulness. □

Therefore for a simplicial space X_\bullet we can replace the associated non-strict cosimplicial diagram $\mathcal{F}(X_\bullet)$ by a strict cosimplicial diagram $\tilde{\mathcal{F}}(X_\bullet)$. From now on when we talk about the totalization, homotopy limit or Reedy fibrancy of $\mathcal{F}(X_\bullet)$, we always mean the corresponding construction or property of $\tilde{\mathcal{F}}(X_\bullet)$.

Remark 4.2. In this paper, rectification will be used mainly in Section 4.6 below.

4.2 A criterion of Reedy fibrancy

Before moving on to examples, we want to have a criterion on the Reedy fibrancy of $\mathcal{F}(X_\bullet)$. First recall the definition of split simplicial spaces.

Definition 4.2 ([DHI04] Definition 4.13). A simplicial space X_\bullet is said to be *split*, or to *have free degeneracies*, if there exist subspaces $N_k \hookrightarrow X_k$ such that the canonical maps

$$N_k \coprod L_k X \rightarrow X_k$$

are isomorphisms for all $k \geq 0$, where $L_k X$ is the k -th latching object of X_\bullet . This is equivalent to requiring that the canonical map

$$\coprod_{\sigma} N_{\sigma} \rightarrow X_k$$

is an isomorphism, where the variable σ ranges over all surjective maps in Δ of the form $[k] \rightarrow [n]$, N_{σ} denotes a copy of N_n , and the map $N_{\sigma} \rightarrow X_k$ is the one induced by $\sigma^* : X_n \rightarrow X_k$.

The idea is that the objects N_k represent the non-degenerate part of X_\bullet in dimension k , and that the leftover degenerate part is as free as possible.

Proposition 7. *Let $\mathcal{F} : S^{op} \rightarrow \text{dgCat}$ be a functor which sends finite coproducts to products. Then for any split simplicial object X_\bullet in \mathcal{S} , the cosimplicial object $\mathcal{F}(X_\bullet)$ is Reedy fibrant.*

Proof. First we notice that if $\mathcal{F} : S^{op} \rightarrow \text{dgCat}$ sends finite coproducts to products, then so is $\tilde{\mathcal{F}}$. Now it is sufficient to show that the natural map $\tilde{\mathcal{F}}(X_k) \rightarrow M_k(\tilde{\mathcal{F}}(X_\bullet))$ is a fibration in dgCat_{DK} for any $k \geq 0$, where $M_k(\tilde{\mathcal{F}}(X_\bullet))$ is the k th matching object of $\tilde{\mathcal{F}}(X_\bullet)$. Recall by Tabuada's definition [Tab05b] of Dwyer-Kan model structure on dgCat , a functor $G : \mathcal{C} \rightarrow \mathcal{D}$ of dg-categories is a fibration if:

F1 G induces surjections on Hom-spaces.

F2 Given $u : G(c) \rightarrow d$ such that $[u]$ is an isomorphism in $\text{Ho}(\mathcal{D})$, there is $v : c \rightarrow c'$ such that $G(c') = d$ and $F(v) = u$.

We need the following lemma on the matching object.

Lemma 3. *Let $\tilde{\mathcal{F}} : S^{op} \rightarrow \text{dgCat}$ be a functor which sends finite coproducts to products. Let X_\bullet be a split simplicial object and $\coprod_{\sigma} N_{\sigma} \xrightarrow{\cong} X_k$ is given as in Definition 4.2. Then for any $k \geq 0$ the k th matching object $M_k(\tilde{\mathcal{F}}(X_\bullet))$ is isomorphic to*

$$\prod_{\substack{\sigma : [k] \rightarrow [n] \text{ surjective} \\ n < k}} \tilde{\mathcal{F}}(N_{\sigma}).$$

Proof of Lemma 3. Since X_\bullet is split and $\tilde{\mathcal{F}}$ sends finite coproducts to products, we get

$$\tilde{\mathcal{F}}(X_k) = \prod_{\sigma : [k] \rightarrow [n] \text{ surjective}} \tilde{\mathcal{F}}(N_{\sigma}).$$

Then the result of Lemma 3 is clear from the construction of the matching object. \square

By Lemma 3 we know that $\tilde{\mathcal{F}}(X_k) = \tilde{\mathcal{F}}(N_k) \oplus M_k(\tilde{\mathcal{F}}(X_\bullet))$. The natural map $\tilde{\mathcal{F}}(X_k) \rightarrow M_k(\tilde{\mathcal{F}}(X_\bullet))$ is exactly the projection onto the second summand hence by definition it is a fibration. We finishes the proof of Proposition 7. \square

4.3 Twisted complexes

In this subsection by ringed space we mean a topological space X together with a sheaf of (not necessarily commutative) ring \mathcal{R} on X . Examples include

- A scheme X with the structure sheaf \mathcal{O}_X ;
- A complex manifold X with the sheaf of analytic functions \mathcal{O}_X ;
- A topological space X with the constant sheaf of rings \mathbb{C} ;
- A scheme X with the sheaf of rings of differential operators \mathcal{D}_X .

Let

$$Cpx : \text{Space}^{op} \rightarrow \text{dgCat}$$

be the contravariant functor which assigns to each ringed space X the dg-category of complexes of left \mathcal{R} -modules on X . This is a presheaf of dg-categories.

Remark 4.3. In practice we are often less interested in the category of all complexes \mathcal{R} -modules than in some well-behaved subcategory, say complexes with quasi-coherent cohomology on a scheme, or \mathcal{D}_X -modules which are quasi-coherent as \mathcal{O}_X -modules. As long as the condition we impose is local the theory works equally well in those cases. We will explicitly consider the case of perfect complexes in the next section.

Remark 4.4. In this subsection by \mathcal{R} -modules we always mean left \mathcal{R} -modules, unless it is explicitly pointed out otherwise.

Let (X, \mathcal{R}) be a ringed space and $\mathcal{U} = \{U_i, i \in I\}$ be a locally finite open cover of X . We consider the Čech nerve of the covering \mathcal{U} , $N(\mathcal{U})$, which is a simplicial space

$$\coprod U_i \rightrightarrows \coprod U_i \cap U_j \rightrightarrows \coprod U_i \cap U_j \cap U_k \cdots$$

For simplicity let $U_{i_0 \dots i_n}$ denote the intersection $U_{i_0} \cap \dots \cap U_{i_n}$. Moreover we use the notation N_\bullet to denote the Čech nerve, i.e. we have

$$N_k = \coprod_{(i_0 \dots i_k)} U_{i_0 \dots i_k} \text{ for any } k \geq 0.$$

Therefore

$$Cpx(N_k) = \coprod_{(i_0 \dots i_k)} Cpx(U_{i_0 \dots i_k}) \text{ for any } k \geq 0.$$

We get a cosimplicial diagram of dg-categories

$$Cpx(N_0) \rightrightarrows Cpx(N_1) \rightrightarrows Cpx(N_2) \cdots \quad (15)$$

Remark 4.5. Note that Diagram 15 is a strict cosimplicial diagram because the coface maps are given by restrictions to open subsets. Therefore we do not need to rectify the diagram.

We want to achieve an explicit description of the homotopy limit of Diagram 15. For this we introduce *twisted complexes*.

Let us first set up some notations. For each U_{i_k} , let $E_{i_k}^\bullet$ be a graded sheaf of \mathcal{R} -modules on U_{i_k} . Let

$$C^\bullet(\mathcal{U}, E^\bullet) = \prod_{p,q} C^p(\mathcal{U}, E^q) \quad (16)$$

be the bigraded complexes of E^\bullet . More precisely, an element $c^{p,q}$ of $C^p(\mathcal{U}, E^q)$ consists of a section $c_{i_0 \dots i_p}^{p,q}$ of $E_{i_0}^q$ over each non-empty intersection $U_{i_0 \dots i_p}$. If $U_{i_0 \dots i_p} = \emptyset$, simply let the component on it be zero.

Now if another graded sheaf $F_{i_k}^\bullet$ of \mathcal{R} -modules is given on each U_{i_k} , then we can consider the map

$$C^\bullet(\mathcal{U}, \text{Hom}^\bullet(E, F)) = \prod_{p,q} C^p(\mathcal{U}, \text{Hom}^q(E, F)). \quad (17)$$

An element $u^{p,q}$ of $C^p(\mathcal{U}, \text{Hom}^q(E, F))$ gives a section $u_{i_0 \dots i_p}^{p,q}$ of $\text{Hom}_{\mathcal{R}\text{-Mod}}^q(E_{i_p}^\bullet, F_{i_0}^\bullet)$, i.e. a degree q map from $E_{i_p}^\bullet$ to $F_{i_0}^\bullet$ over the non-empty intersection $U_{i_0 \dots i_p}$. Notice that we require $u^{p,q}$ to be a map from the E on the last subscript of $U_{i_0 \dots i_p}$ to the F on the first subscript of $U_{i_0 \dots i_p}$. Again, if $U_{i_0 \dots i_p} = \emptyset$, let the component on it be zero.

The compositions of $C^\bullet(\mathcal{U}, \text{Hom}^\bullet(E, F))$ is the shuffled multiplication given in Section 3.1 Equation (7). In particular $C^\bullet(\mathcal{U}, \text{Hom}^\bullet(E, E))$ becomes an associative algebra under this composition (It is easy but tedious to check the associativity).

There are also Čech-style differential operator δ on $C^\bullet(\mathcal{U}, \text{Hom}^\bullet(E, F))$ of bidegree $(1, 0)$ given by the following formula which is similar to Equation (6).

$$(\delta u)_{i_0 \dots i_{p+1}}^{p+1,q} = \sum_{k=1}^p (-1)^k u_{i_0 \dots \widehat{i_k} \dots i_{p+1}}^{p,q} |_{U_{i_0 \dots i_{p+1}}} \text{ for } u^{p,q} \in C^p(\mathcal{U}, \text{Hom}^q(E, F)). \quad (18)$$

Caution 1. Notice that the map δ defined above is different from the usual Čech differential since we do not include the 0th and the $p+1$ th indices.

Proposition 8. *The differential satisfies the Leibniz rule. More precisely we have*

$$\delta(u \cdot v) = (\delta u) \cdot v + (-1)^{|u|} u \cdot (\delta v)$$

and

$$\delta(u \cdot c) = (\delta u) \cdot c + (-1)^{|u|} u \cdot (\delta c)$$

where $|u|$ is the total degree of u .

Proof. This is a routine check. □

Now we can define twisted complexes.

Definition 4.3 ([OTT81b] Definition 1.3 or [Wei16] Definition 5). Let (X, \mathcal{R}) be a ringed space and $\mathcal{U} = \{U_i\}$ be a locally finite open cover of X . A *twisted complex* consists of a graded sheaves E_i^\bullet of \mathcal{R} -modules on each U_i together with

$$a = \sum_{k \geq 0} a^{k, 1-k}$$

where $a^{k, 1-k} \in C^k(\mathcal{U}, \text{Hom}^{1-k}(E, E))$ such that they satisfy the Maurer-Cartan equation

$$\delta a + a \cdot a = 0. \quad (19)$$

More explicitly, for $k \geq 0$ and all multi-index $(i_0 \dots i_k)$ we have

$$\sum_{j=1}^{k-1} (-1)^j a_{i_0 \dots \widehat{i_j} \dots i_k}^{k-1, 2-k} + \sum_{l=0}^k (-1)^{(1-l)(k-l)} a_{i_0 \dots i_l}^{l, 1-l} a_{i_{l+1} \dots i_k}^{k-l, 1-k+l} = 0. \quad (20)$$

Moreover we impose the following non-degenerate condition: for each i , the chain map

$$a_{ii}^{1,0} : (E_i^\bullet, a_i^{0,1}) \rightarrow (E_i^\bullet, a_i^{0,1}) \text{ is invertible up to homotopy.} \quad (21)$$

The twisted complexes on $(X, \mathcal{R}, \{U_i\})$ form a dg-category: the objects are the twisted complexes $\mathcal{E} = (E_i^\bullet, a)$ and the morphism from $\mathcal{E} = (E_i^\bullet, a)$ to $\mathcal{F} = (F_i^\bullet, b)$ are $C^\bullet(\mathcal{U}, \text{Hom}^\bullet(E, F))$ with the total degree. Moreover, the differential on a morphism ϕ is given by

$$d\phi = \delta\phi + b \cdot \phi - (-1)^{|\phi|} \phi \cdot a. \quad (22)$$

We denote the dg-category of twisted complexes on $(X, \mathcal{R}, \{U_i\})$ by $\text{Tw}(X, \mathcal{R}, \{U_i\})$. If there is no risk of confusion we can simply denote it by $\text{Tw}(X)$.

For more details on twisted complexes see [Wei16]. In this paper we want to find the relation between twisted complexes and $Cpx(N_\bullet)$ where N_\bullet is the Čech nerve of \mathcal{U} . Our first result is the following proposition.

Proposition 9. *Let (X, \mathcal{R}) be a ringed space and $\mathcal{U} = \{U_i\}$ be a locally finite open cover of X . Recall that we use N_\bullet to denote the classifying space of $\{U_i\}$. Then the dg-category of twisted complexes $\text{Tw}(X, \mathcal{R}, \{U_i\})$ is exactly the totalization of the cosimplicial object $\text{Cpx}(N_\bullet)$ in dgCat_{DK} .*

Proof. First notice that Remark 4.5 tells us we do not need to rectify the diagram.

We need to compare Theorem 2 and Definition 4.3. The apparent difference between these two is that in Theorem 2 we only take $(0 \dots k)$ as the multi-index while in Definition 4.3 we take all multi-indices. The problem is solved once we notice that

$$N_k = \coprod_{(i_0 \dots i_k)} U_{i_0 \dots i_k}$$

and therefore for all $k \geq 1$ the $\phi_{0 \dots k}^{k, 1-k}$ gives an $a_{i_0 \dots i_k}^{k, 1-k}$ on each $U_{i_0 \dots i_k}$. For $k = 0$ we do not have $\phi_0^{0, 1}$ but we know that

$$a_{i_0}^{0, 1} \cdot a_{i_0 \dots i_k}^{k, 1-k} + a_{i_0 \dots i_k}^{k, 1-k} \cdot a_{i_k}^{0, 1} = (-1)^k d(a_{i_0 \dots i_k}^{k, 1-k}).$$

As a result we get the correspondence between Equation (12) and Equation (20).

As for the non-degenerate condition, by the $k = 2$ case of the Maurer-Cartan equation we have

$$-a_{ii}^{1, 0} + a_{ij}^{1, 0} \cdot a_{ji}^{1, 0} + a_i^{0, 1} \cdot a_{ij}^{2, -1} + a_{ji}^{2, -1} \cdot a_i^{0, 1} = 0.$$

In other words $a_{ii}^{1, 0}$ is homotopic to $a_{ij}^{1, 0} \cdot a_{ji}^{1, 0}$ hence $a_{ii}^{1, 0}$ is invertible in the homotopy category for each i implies that $a_{ij}^{1, 0}$ is also invertible in the homotopy category for each i, j . Therefore the two version of non-degenerate conditions are equivalent.

The proof of the equivalence between the morphism is the same. \square

Next we want to study the relation between the twisted complexes and the homotopy limit. For this purpose we need to determine whether $\text{Cpx}(N_\bullet)$ is Reedy fibrant. In fact the following proposition gives an affirmative answer.

Proposition 10. *Let (X, \mathcal{R}) be a ringed space and $\mathcal{U} = \{U_i\}$ be a locally finite open cover of X . Let N_\bullet be the classifying space of $\{U_i\}$ as before. Then $\text{Cpx}(N_\bullet)$ is a Reedy fibrant cosimplicial object in dgCat_{DK} .*

Proof. It is easy to show that the Čech nerve of an open cover is a split simplicial space. It is also clear that the functor Cpx sends finite coproducts to products hence the claim of Proposition 10 is a direct corollary of Proposition 7. \square

Corollary 3. *Let (X, \mathcal{R}) be a ringed space and $\mathcal{U} = \{U_i\}$ be a locally finite open cover of X . Let N_\bullet be the classifying space of $\{U_i\}$ as before. Then the dg-category of twisted complexes $\text{Tw}(X, \mathcal{R}, \{U_i\})$ gives an explicit construction of $\text{holim Cpx}(N_\bullet)$.*

Proof. It is a direct corollary of Corollary 2 and Proposition 10. \square

It is clear that Corollary 3 applies to the following cases

- For a scheme (X, \mathcal{O}_X) , $\text{Tw}(X, \mathcal{O}_X, \{U_i\})$ is quasi-equivalent to the homotopy limit of sheaves of \mathcal{O} -modules on the nerve;
- Similarly for a complex manifold (X, \mathcal{O}_X) , $\text{Tw}(X, \mathcal{O}_X, \{U_i\})$ gives $\text{holim Cpx}_{\mathcal{O}\text{-mod}}(N_\bullet)$;
- For a scheme X with the sheaf of rings of differential operators \mathcal{D}_X we obtain a category of twisted complexes of \mathcal{D}_X -modules, $\text{Tw}(X, \mathcal{D}_X, \{U_i\})$, which is quasi-equivalent to $\text{holim Cpx}_{\mathcal{D}\text{-mod}}(N_\bullet)$;
- For a topological space X with the constant sheaf of rings \mathbb{C} we obtain $\text{Tw}(X, \mathbb{C}, \{U_i\})$ as a model for $\text{holim}_{\mathbb{C}\text{-mod}}(N_\bullet)$. By inspection this is equivalent to the dg-category of ∞ -local systems on N_\bullet , see [Hol14]. If we now assume that the cover \mathcal{U} is good, i.e. all opens and their intersections are contractible, then this nerve is homotopy equivalent to singular simplices on X , and ∞ -local systems on the nerve are just sheaves of \mathbb{C} -modules on X that are homotopy locally constant, see [Hol15a] for more on this situation.

Remark 4.6. Note that twisted complexes of \mathcal{D} -modules are not to be confused with twisted \mathcal{D} -modules on X , which are completely different objects.

Remark 4.7. We can also extend this to Grothendieck topologies. For example, let X be a variety (or scheme, or algebraic stack) equipped with a locally finite étale cover \mathcal{U} . We consider a sheaf of rings \mathcal{R}_X on the étale site, for example the constant sheaf \mathbf{Z}/ℓ , and write Cpx for the category of \mathcal{R}_X -modules. We may then define $Tw(X, \mathcal{R}_X, \mathcal{U})$. After rectifying the diagram $Cpx(N_\bullet)$ we can show the analogue of Proposition 9. It is clear that the nerve of \mathcal{U} is split, thus an analogue of Corollary 3 also holds and $Tw(X, \mathcal{R}_X, \mathcal{U}) \simeq \text{holim } Cpx(N_\bullet)$.

A potentially interesting object of study would be to take a colimit over all étale hypercovers of X , as one does when studying the étale homotopy type. Note that we consider colimits of hypercovers in Section 4.5, but we will not return to this example.

4.4 Twisted perfect complexes

We are often not interested in all \mathcal{R} -modules but only some more convenient subcategory. If the sheaf of ring \mathcal{R} is commutative, we can also consider the contravariant functor

$$Perf : \text{Space}^{op} \rightarrow \text{dg-Cat}$$

which assigns to each ringed space X the dg-category of strictly perfect complexes of \mathcal{R} -modules on X . As before let $\mathcal{U} = \{U_i\}$ locally finite open cover of X and $N_k = \coprod U_{i_0 \dots i_k}$ be the nerve of the cover. Similar to Diagram 1 we have a cosimplicial diagram of dg-categories.

$$Perf(N_0) \rightrightarrows Perf(N_1) \rightrightarrows Perf(N_2) \cdots \quad (23)$$

We also have the following variant of twisted complexes.

Definition 4.4. A *twisted perfect complex* $\mathcal{E} = (E_i^\bullet, a)$ is the same as twisted complex in Definition 4.3 except that each E_i^\bullet is a strictly perfect complex on U_i .

The twisted perfect complexes also form a dg-category and we denote it by $\text{Tw}_{\text{perf}}(X, \mathcal{R}, \{U_i\})$ or simply $\text{Tw}_{\text{perf}}(X)$. Obviously $\text{Tw}_{\text{perf}}(X)$ is a full dg-subcategory of $\text{Tw}(X)$.

We have the following result for twisted perfect complexes which is similar to Proposition 9 and Corollary 3.

Proposition 11. *Let (X, \mathcal{R}) be a ringed space and $\mathcal{U} = \{U_i\}$ be a locally finite open cover of X . Then the dg-category of twisted complexes $\text{Tw}_{\text{perf}}(X, \mathcal{R}, \{U_i\})$ is exactly the totalization of the cosimplicial object $Perf(N_\bullet)$ in dgCat_{DK} and further weakly equivalent to the homotopy limit of $Perf(N_\bullet)$.*

Proof. Since $Perf$ also send finite coproducts to products, the proof is exactly the same as that of Proposition 9 and Corollary 3. \square

The significance of twisted perfect complexes in geometry is given by the construction in [OTT81a]. Moreover, we have the following result:

Theorem 3. *[[Wei16] Theorem 4] Let X be a quasi-compact and separated or Noetherian scheme and $\{U_i\}$ be an affine cover, then $\text{Tw}_{\text{perf}}(X)$ gives a dg-enhancement of $D_{\text{perf}}(X)$, the derived category of perfect complexes on X .*

Proof. See [Wei16] Theorem 4. \square

Remark 4.8. A systematic study of presheaves valued in sSet has been given in [DHI04] and in [Hol15a] Section 3.1 some results on the presheaves valued in dgCat has been achieved. We expect that the result in this section can help us further study the presheaves in dgCat .

4.5 The stack of twisted perfect complexes

In this subsection we assume that (X, \mathcal{R}) is a hereditarily paracompact ringed space with a basis \mathcal{P} of p -good open sets.

Recall from Section 3.3.2 of [Wei16] the following notation:

Definition 4.5. A locally ringed space (U, \mathcal{O}_U) is *p -good* if any perfect complex of quasi-coherent sheaves on U is quasi-isomorphic to a strictly perfect complex and quasi-coherent sheaves on U have no higher cohomology. A *p -good cover* is a cover such that its nerve consists of a coproduct of p -good spaces in every degree.

Interesting examples of p -good spaces are affine algebraic varieties, Stein spaces and contractible topological spaces whose structure sheaf is constant.

Thus our assumptions are satisfied by the following examples:

- separated schemes with \mathcal{P} given by affine subschemes,
- complex manifolds with \mathcal{P} given by Stein subspaces,
- locally contractible hereditarily paracompact topological spaces with constant structure sheaf, where \mathcal{P} is any choice of a contractible basis.

Remark 4.9. Note that as contractible open sets are not closed under intersection we have to make some choice in the last class of examples.

Now let \mathcal{C} be the category given by a class of ringed spaces satisfying our assumptions. Open covers of topological spaces form the basis of a Grothendieck topology τ on \mathcal{C} , giving us a site (\mathcal{C}, τ) .

We note that (\mathcal{C}, τ) is a Verdier site. A Verdier site is just a Grothendieck site with a basis such that if $U \rightarrow X$ is a covering family then so is $U \rightarrow U \times_X U$. See Section 8 of [DHI04] for details. (Another example of a Verdier site is given by the étale topology on schemes.)

Let $y : \mathcal{C} \rightarrow PSh(\mathcal{C}, \tau)$ be the Yoneda embedding.

Definition 4.6. A *hypercouver* $\mathcal{U} = \{U_\bullet\}$ of an object $X \in \mathcal{C}$ is an augmented simplicial presheaf $U_\bullet \rightarrow y_X$ on (\mathcal{C}, τ) such that all U_n are coproducts of representables and all $U_n \rightarrow M_n U$ are in τ . (Here matching objects are computed over y_X , in particular $M_0 U = y_X$.)

Remark 4.10. In [DHI04] these are called basal hypercovers, but Theorem 8.6 in loc. cit. shows that any hypercover has a basal refinement. We explain below that this means it is enough to work with basal hypercovers.

The canonical example of a hypercover is the nerve of a Čech covering.

We say a hypercover is *locally finite* if every cover $U_n \rightarrow M_n U$ is locally finite. A hypercover is *split* if it satisfies Definition 4.2 (replacing spaces by presheaves). Given a collection \mathcal{P} of open sets a hypercover is a \mathcal{P} -*hypercouver* if in every degree it consists of a coproduct of (sheaves represented by) objects in \mathcal{P} .

The morphisms between hypercovers are *refinements*, where we say $\mathcal{U} \rightarrow X$ is a refinement of $\mathcal{V} \rightarrow X$ if it factors through $\mathcal{V} \rightarrow X$, i.e. there are compatible factorizations $U_n \rightarrow V_n$ for every n . We call a refinement by a \mathcal{P} -hypercouver a \mathcal{P} -*refinement*.

Now we note that we can define twisted complexes on a (locally finite) hypercover just as well as on a cover. Moreover, Proposition 10 and Proposition 11 still hold if N_\bullet is a split hypercover. In the proof we only needed that N_\bullet is split, not that it is the nerve of a cover.

There is a contravariant functor of twisted complexes from the category of all locally finite hypercovers \mathcal{U} of X to dgCat that sends a refinement to the functor induced by restriction.

The class of all hypercovers is too large and we will work with the following smaller category of hypercovers:

Definition 4.7. Let $HC(X)$ denote the subcategory of locally finite, split \mathcal{P} -hypercouver of X . We will sometimes write HC if X is clear from context.

Remark 4.11. In the example of topological spaces with constant structure sheaf the choice of \mathcal{P} is not canonical, we need to choose \mathcal{P} for every X . But there are no compatibility conditions, and different choices of \mathcal{P} do not affect the results.

Twisted complexes as we have defined them depend on a choice of hypercover. We now need to turn them into a functor on \mathcal{C} . Let $\mathcal{C}_\mathcal{V}$ be the category whose objects are given by pairs (X, \mathcal{V}) where $X \in \mathcal{C}$ and $\mathcal{V} \in HC(X)$, with morphisms given by maps of ringed spaces that are compatible with the hypercovers.

There is a natural forgetful functor $u : \mathcal{C}_\mathcal{V} \rightarrow \mathcal{C}$ which is full.

Definition 4.8. We denote by $Tw_{perf} : \mathcal{C}^{op} \rightarrow \text{dgCat}$ the homotopy left Kan extension along u of the natural functor $Tw_{perf} : \mathcal{C}_\mathcal{V}^{op} \rightarrow \text{dgCat}$ given by $(X, \mathcal{V}) \mapsto Tw_{perf}(X, \mathcal{R}_X, \mathcal{V})$ on objects and by restriction on morphisms.

Recall that the *left Kan extension*, or the *relative colimit*, of a functor $T : A \rightarrow D$ along a functor $p : A \rightarrow B$ is defined by applying the left adjoint $p_!$ (if it exists) of the restriction functor $p^* : Fun(B, D) \rightarrow Fun(A, D)$ to T . The special case that B is the 1-object category recovers the colimit of T . If D is a model category then there is the corresponding notion of the homotopy left Kan extension, obtained as the left derived functor of $p_!$. See for example Section 10 of [Dug] for more details.

Remark 4.12. Note that to construct the left Kan extension we need our index categories to be small. We may either restrict attention to a small subcategory of \mathcal{C} , or avoid this condition by assuming the existence of a suitable Grothendieck universe.

Our new definition of twisted complexes looks rather unwieldy, but we will show that we can still compute twisted complexes on X using any hypercover in $HC(X)$.

First we recall two very useful lemmas about computing homotopy colimits. Given a functor $\iota : I \rightarrow J$, recall the natural map $e_j : (j \downarrow \iota) \rightarrow J$ from the undercategory, sending $(i, j \rightarrow \iota(i))$ to $\iota(i)$.

Lemma 4. *Let $\iota : I \rightarrow J$ be a functor between small categories such that for every $j \in J$ the undercategory $(j \downarrow \iota)$ is nonempty with a contractible nerve (we say ι is homotopy terminal) and let $X : J \rightarrow \mathcal{M}$ be a diagram with values in a model category. Then the map $\text{hocolim}_I \iota^* X \rightarrow \text{hocolim}_J X$ is a weak equivalence.*

Lemma 5. *Let $\iota : I \rightarrow J$ be a functor between small categories and let $X : J \rightarrow \mathcal{M}$ a diagram with values in a model category. Suppose that the composition*

$$\text{hocolim}_{(j \downarrow \iota)} e_j^*(X) \rightarrow \text{colim}_{(j \downarrow \iota)} e_j^*(X) \rightarrow X_j$$

is a weak equivalence for every j . Then the natural map $\text{hocolim}_I \iota^ X \rightarrow \text{hocolim}_J X$ is a weak equivalence.*

Proofs. For topological spaces these are Theorems 6.7 and 6.9 of [Dug] and the proofs (in Section 9.6) do not depend on the choice of model category. \square

Lemma 6. *$Tw_{perf}(X, \mathcal{R}) \simeq \text{hocolim}_{\mathcal{U} \in HC(X)^{op}} Tw_{perf}(X, \mathcal{R}, \mathcal{U})$ where we take the homotopy colimit over the opposite of the category of locally finite, split \mathcal{P} -hypercovers \mathcal{U} of X .*

Proof. We first use the pointwise computation of a homotopy left Kan extensions to deduce that $Tw_{perf}(X, \mathcal{R}) = \text{hocolim}_{\mathcal{C}_V^{op}/X} Tw_{perf}(Y, \mathcal{R}_Y, \mathcal{V})$. This is a special case of base change for relative colimits. See Proposition 10.2 of [Dug], or Theorem 9.6.5 in [Rad06] for base change in the more general setting of relative categories.

To simplify this computation we then use 4 to show that the homotopy colimit can also be computed over $HC(X)^{op}$. To do this we need to show that the inclusion $\iota : HC(X)^{op} \rightarrow \mathcal{C}_V^{op}/X$ is homotopy terminal. For every $(Y, \mathcal{V}) \in \mathcal{C}_V$ with $f : X \rightarrow Y$ we need to show that $\iota \downarrow (Y, \mathcal{V})$ is contractible.

We note that $f^{-1}(\mathcal{V})$ is a hypercover of X , and it is clear that working over (Y, \mathcal{V}) is equivalent to working over $f^{-1}(\mathcal{V})$.

Contractibility of the overcategory follows if we can find an object $\mathcal{U} \in HC(X)$ such that the overcategory has all products with \mathcal{U} . First assume we have a well-defined endofunctor $\mathcal{W} \rightarrow \mathcal{W} \times_{f^{-1}(\mathcal{V})} \mathcal{U}$. Then the projection maps give natural transformations to the identity functor and projection to \mathcal{U} . On taking the nerve this gives a homotopy equivalence from the nerve of $\iota \downarrow f^{-1}(\mathcal{V})$ to a point.

We will now construct a (locally finite, split) \mathcal{P} -refinement \mathcal{U} of $f^{-1}(\mathcal{V})$ that behaves like a hypercover of $f^{-1}(\mathcal{V})$. We will now abuse notation and write $f^{-1}(\mathcal{V})$ as \mathcal{V} for ease of notation. To be precise, we will inductively construct \mathcal{U} as a hypercover over \mathcal{V} that moreover satisfies the condition that $U_0 \rightarrow V_0$ and all $U_n \rightarrow M_n U \times_{M_n V} V_n$ are coverings. For the base case we write $V_0 = \coprod_i V_{0,i}$ and choose a locally finite covering of each $V_{0,i}$ using paracompactness. U_0 is their disjoint union. To check this covering is locally finite take $x \in X$, then $f(x) \in Y$ has a neighbourhood W only intersecting finitely many $V_{0,i}$, and $f^{-1}(W)$ intersects only finitely many summands of U_0 . For the induction step we note that $M_n U \times_{M_n V} V_n$ is again a coproduct of representables (this is true for M_n by Lemma 8.4 in [DHI04], and then it easily follows for the fiber product). So we can find a locally finite \mathcal{P} -cover $U_n^* \rightarrow M_n U \times_{M_n V} V_n$ by the same argument as above, and let $U_n = U_n^* \coprod L_n U$. To see that this map is basal see the proof of Theorem 8.6 in [DHI04]. It is split by construction.

Given $\mathcal{U} \rightarrow \mathcal{V}$ as above and any refinement $\mathcal{W} \in HC(X)$ of \mathcal{V} we can construct the levelwise pullback. It clearly satisfies the universal property. Now Lemma 7.1 in [Sta17] shows that a fiber product $\mathcal{U} \times_{\mathcal{V}} \mathcal{W}$ of hypercovers is a hypercover if $U_0 \rightarrow V_0$ and $U_n \rightarrow M_n U \times_{M_n V} V_n$ are coverings, which is true in our case by construction of \mathcal{U} . It remains to check that $\mathcal{U} \times_{\mathcal{V}} \mathcal{W}$ is a \mathcal{P} -hypercover, locally finite and split. It is locally finite as \mathcal{U} and \mathcal{W} are. Similarly, it is a disjoint union of objects in \mathcal{P} since the levelwise pullback is just a disjoint union of intersections, and \mathcal{P} is closed under intersections. Finally, $\mathcal{U} \times_{\mathcal{V}} \mathcal{W}$ is split. We use that a hypercover \mathcal{U} is split if $U_n = \coprod_{[n] \rightarrow [k]} N_k$ where the index goes over all surjections, see Definition 4.2. If now $V_n = \coprod_{[n] \rightarrow [k]} M_k$ and $W_n = \coprod_{[n] \rightarrow [k]} L_k$ then we can write

$$U_n \times_{V_n} W_n = \coprod_{[n \rightarrow k_1], [n \rightarrow k_2], [n \rightarrow k_3]} N_{k_1} \times_{M_{k_2}} L_{k_3}.$$

We define $K_n = \coprod_{[m \rightarrow k_1], [m \rightarrow k_2], [m \rightarrow k_3]}^* N_{k_1} \times_{M_{k_2}} L_{k_3}$ where the asterisk indicates that we leave out from the indexing set all pairs of maps which factor through a common $[m \rightarrow m-1]$. Then $\mathcal{U} \times_{\mathcal{V}} \mathcal{W}$ is split with free degeneracies K_n in degree n . \square

Lemma 7. *There is a weak equivalence $Tw_{perf}(X, \mathcal{R}, \mathcal{U}) \simeq Tw_{perf}(X, \mathcal{R})$ for any hypercover \mathcal{U} in HC . In particular $Tw_{perf}(X, \mathcal{R}) \simeq Mod(\mathcal{R}(X))_{perf}^{cf}$ if X itself is in \mathcal{P} . Here the right hand side is the dg-category of fibrant and cofibrant complexes of $\mathcal{R}(X)$ -modules which are perfect.*

Proof. Let us fix \mathcal{U} . By Lemma 6 it suffices to compare $Tw(X, \mathcal{R}, \mathcal{U})$ with $\text{hocolim}_{HC^{op}} Tw_{perf}(X, \mathcal{R}, \mathcal{W})$.

We consider the category $HC_{\mathcal{U}}$ of all hypercovers in HC that are refinements of \mathcal{U} . First, we examine the inclusion $\iota : HC_{\mathcal{U}} \rightarrow HC$. We claim that $HC_{\mathcal{U}}^{op}$ is homotopy terminal in HC^{op} , i.e. that ι is homotopy initial. We have to show that for any $\mathcal{V} \in HC$ the overcategory $(\iota \downarrow \mathcal{V})$ is nonempty and contractible.

This follows since it has a terminal object given by $\mathcal{U} \times_X \mathcal{V}$. This clearly satisfies the universal property, we just have to show it is in HC . Note that the fiber product is given by $U_n \times_X V_n$ in degree n . It is a hypercover by Lemma 7.2 in [Sta17] and is easily seen to be locally finite. Moreover, in every degree it is a coproduct of finite intersections of objects in \mathcal{P} , this $\mathcal{U} \times_X \mathcal{V}$ is a \mathcal{P} -hypercover. Finally, the fiber product is split by the argument from the previous lemma.

By Lemma 4 we now have

$$\text{hocolim}_{\mathcal{V} \in HC_{\mathcal{U}}^{op}} Tw_{perf}(X, \mathcal{R}, \mathcal{V}) \simeq \text{hocolim}_{\mathcal{W} \in HC^{op}} Tw_{perf}(X, \mathcal{R}, \mathcal{W}) \simeq Tw_{perf}(X, \mathcal{R}).$$

Secondly, we consider the inclusion of the 1-object category $\{\mathcal{U}\}$ in $HC_{\mathcal{U}}^{op}$. We claim that $Tw_{perf}(X, \mathcal{R}, \mathcal{U}) \simeq Tw_{perf}(X, \mathcal{R}, \mathcal{V})$ for any $\mathcal{V} \in HC_{\mathcal{U}}^{op}$.

By Theorem 3.15 of [Wei16] we know that both sides are enhancements of $D_{perf}(QCoh(X))$, i.e. their homotopy categories agree. But the results of that paper readily imply a stronger result. The functor \mathcal{S} defined in Definition 3.2 of [Wei16] is a dg-functor from $Tw_{perf}(X, \mathcal{R}, \mathcal{U})$ to $QCoh(X, \mathcal{R})$. The right hand side is a model category and we may compose \mathcal{S} with functorial fibrant cofibrant replacement. We claim this functor gives a DK equivalence $Tw_{perf}(X, \mathcal{R}, \mathcal{U}) \rightarrow QCoh(X, \mathcal{R})_{perf}^{cf}$. Here the homotopy category of the right hand side is the derived category. That the functor lands in perfect complexes and is quasi-essentially surjective is immediate from the results of [Wei16]. Since the functor is compatible with shifts and induces isomorphisms on H^0 it induces isomorphisms on all the cohomology groups of the Hom-complexes. This shows it is quasi-fully faithful. Thus $Tw_{perf}(X, \mathcal{R}, \mathcal{U}) \simeq Tw_{perf}(X, \mathcal{R}, \mathcal{V})$ as claimed.

But then by Lemma 5 applied to the inclusion of $\{\mathcal{U}\}$ in $HC_{\mathcal{U}}^{op}$ we have

$$Tw_{perf}(X, \mathcal{R}, \mathcal{U}) \simeq \text{hocolim}_{\mathcal{V} \in HC_{\mathcal{U}}^{op}} Tw_{perf}(X, \mathcal{R}, \mathcal{V}).$$

Putting this together with the first weak equivalence completes the proof.

For the special case we just consider the nerve of the trivial cover $X \rightarrow X$. \square

Moreover, given any $f : X \rightarrow Y$ the induced map $Tw_{perf}(Y) \rightarrow Tw_{perf}(X)$ may be represented by the natural restriction $f^* : Tw_{perf}(Y, \mathcal{V}) \rightarrow Tw_{perf}(X, \mathcal{U})$ for any pair of good hypercovers compatible with f . (The universal property of the left Kan extension implies that there is natural transformation $Tw_{perf}(X, \mathcal{U}) \rightarrow Tw_{perf}(X)$ in the homotopy category.)

We now turn our attention to showing that Tw_{perf} is a stack. Hypercovers allow us to define the correct higher sheaf condition for presheaves with values in a homotopy category.

Definition 4.9. A presheaf F of dg-categories on a site (\mathcal{C}, τ) is a *stack* or *hypersheaf* if it satisfies the following condition: $F(W) \simeq \text{holim}_i F(U_i)$ for any hypercover $\mathcal{U} = \{U_i\}$ of W . We also say that F *satisfies descent for hypercovers*.

Remark 4.13. Stacks are just the fibrant objects in the model category obtained by localizing at hypercovers, see [DHI04].

Given a presheaf of categories this condition asserts that the global data is glued from local data. Thus it is very important that categories of sheaves on a space satisfy this condition. We will show here directly that twisted perfect complexes do form a stack.

Remark 4.14. Theorem 2.8 of [Sim05] asserts that the functor Cpx^{cf} is a stack, where $Cpx^{cf}(U)$ is the subcategory of fibrant and cofibrant objects in $Cpx(U)$, and a model for the $(\infty, 1)$ -category of sheaves of complexes. In the algebraic geometric setting this has been shown for example in [TV08] or, in great generality, in the language of ∞ -categories in [Lur11a, Lur11b, Gai14].

A collection S of hypercovers is *dense* if every hypercover can be refined by a hypercover in S , and we now show that the hypercovers in $HC(X)$ are dense.

Lemma 8. *If X is a hereditarily paracompact topological space with a basis \mathcal{P} then any hypercover in the site of open subsets of X has a split, locally finite \mathcal{P} -refinement.*

Proof. This follows from the proof of Theorem 8.6 in [DHI04], which shows the existence of a split refinement, and we just need to make the refinement be a locally finite \mathcal{P} -hypercover as well.

In more details let $\mathcal{U} \rightarrow X$ be a hypercover and we know $U_0 \rightarrow X$ is a cover. Since covers in a Verdier site are generated by a basis, there exists a family $W_a \rightarrow X$ and $\coprod_a W_a \rightarrow X$ refines $U_0 \rightarrow X$. As X is paracompact we can further obtain a locally finite \mathcal{P} -refinement of $\coprod_a W_a \rightarrow X$ and we denote it by V_0 . The rest of the proof is the same as the induction procedure in [DHI04] Theorem 8.6 and the refinement as above. \square

Corollary 4. *Moreover, any two hypercovers U and V have a common refinement as above.*

Proof. Given two hypercovers U and V it suffices to pick a refinement as in Lemma 8 for the fiber product $U \times_X V$. \square

The crucial lemma now is the following:

Lemma 9. *Consider a category of presheaves with values in a model category. The homotopy category obtained by localizing at all hypercovers is equivalent to localizing at a dense set of hypercovers. In particular, it suffices to check the stack condition in Definition 4.9 on any dense set of hypercovers.*

Proof. In the case of simplicial presheaves this is Theorem 6.2 in [DHI04]. A general argument can be found in Proposition 4.5.13 in [Ohr], we repeat it here for the reader's convenience. Let H denote the class of hypercovers and H' be a dense subset. It suffices to show that any H -local weak equivalence is also an H' -local weak equivalence. This follows if any map in H is H' -local.

Let $f : X \rightarrow Y$ be in H . As H' is dense there exists $g : Z \rightarrow Y$ in H' such that $f \circ h = g$ for some h . We will show that h is actually an H' -local equivalence. Then f is too, by the 2-out-of-3 property. By the 2-out-of-3 property h must be in H , thus there is $g' : Z' \rightarrow X$ such in H' that $g' = h \circ h'$ for some h' . After localizing at H' we know that $g = fh$ and $g' = hh'$ become equivalences, thus h has a left and a right inverse after localizing and is an H' -equivalence.

It follows that H -local objects and H' -local objects agree, and these are the stacks with respect to hypercovers and with respect to our dense subset of hypercovers. \square

Theorem 4. *Let (\mathcal{C}, τ) be as above. Tw_{perf} is a stack of dg-categories on (\mathcal{C}, τ) .*

Proof. Fix some $X \in \mathcal{C}$. By Lemma 9 it suffices to check the hypersheaf condition for hypercovers in $HC(X)$. We choose a hypercover $\mathcal{V} = \{V_\bullet\}$ in $HC(X)$ and by Proposition 11 and Lemma 7 we have

$$Tw_{perf}(X, \mathcal{R}) \simeq Tw_{perf}(X, \mathcal{R}, \mathcal{V}) \simeq \operatorname{holim}_i Perf(\mathcal{R}(V_i)) \simeq \operatorname{holim}_i Tw_{perf}(V_i, \mathcal{R}). \quad \square$$

4.6 G -equivariant twisted complexes

In this subsection we consider a group action on a space. Let X be a scheme and G be a group scheme. We assume G acts on X from the right. Then we have the associated simplicial scheme $[X/G]_\bullet$ which is defined as follows

$$[X/G]_k = X \times \underbrace{G \times \dots \times G}_k$$

Moreover the face and degeneracy maps in this description are given by the following formula

$$\begin{aligned} \partial_0(x, g_1, \dots, g_k) &= (xg_1, g_2, \dots, g_k), \\ \partial_i(x, g_1, \dots, g_k) &= (x, g_1, \dots, g_i g_{i+1}, \dots, g_k) \text{ if } 1 \leq i \leq k-1, \\ \partial_k(x, g_1, \dots, g_k) &= (x, g_1, \dots, g_{k-1}), \end{aligned}$$

and

$$s_i(x, g_1, \dots, g_k) = (x, g_1, \dots, g_i, e, g_{i+1}, \dots, g_k), \quad 0 \leq i \leq k.$$

Recall that a G -equivariant sheaf on X (see [BL94] Section 0.2) is a pair (E, ϕ) where E is a sheaf on M and ϕ is an isomorphism

$$\phi : \partial_0^*(E) \xrightarrow{\cong} \partial_1^*(E)$$

satisfying the following two conditions

1. The cocycle condition $\partial_1^* \phi = \partial_2^* \phi \circ \partial_0^* \phi$;
2. $s_0^* \phi = id$.

A morphism between G -equivariant sheaves $(E, \phi) \rightarrow (F, \psi)$ is a sheaf map $E \rightarrow F$ which commutes with ϕ and ψ .

Now we consider complexes of sheaves and want a higher version of G -equivariance. One approach is to consider $[X/G]$ as a quotient *stack* and in [Ols07] Olsson developed the theory of derived categories of sheaves on stacks. Note that he is considering cartesian sheaves on a simplicial scheme. The way to relate this to the homotopy limit point of view is to recall that a homotopy limit can also be computed via *strictification*, see discussion and references in [Hol15b].

In this paper we take another approach, i.e. we develop a theory directly from the homotopy limit on the level of dg-categories.

First notice that the usual dg-presheaves $\mathcal{F} : \text{Scheme}^{op} \rightarrow \text{dgCat}$ are actually dg-pseudo-functors hence $\mathcal{F}([X/G]_\bullet)$ is merely a pseudo-cosimplicial object in dgCat . For example $\mathcal{F} = \text{Cpx}$ or Perf . Therefore we need the rectification $\tilde{\mathcal{F}}$ of \mathcal{F} as in Section 4.1.

To state our result we need to define the following maps: For any $k \geq p$ let $\rho_{k,p}$ be the front face map

$$\begin{aligned} \rho_{k,p} : [X/G]_k &\rightarrow [X/G]_p \\ (x, g_1, \dots, g_k) &\mapsto (x, g_1, \dots, g_p) \end{aligned}$$

and $\tau_{k,p}$ be the back face map

$$\begin{aligned} \tau_{k,p} : [X/G]_k &\rightarrow [X/G]_p \\ (x, g_1, \dots, g_k) &\mapsto (x \cdot g_1 \cdot \dots \cdot g_{k-p}, g_{k-p+1}, \dots, g_k) \end{aligned}$$

Proposition 12. *Let X, G and $[X/G]_\bullet$ be as above. Then an object in $\text{Tot}\tilde{\mathcal{F}}([X/G]_\bullet)$ consists of a pair (E, ϕ) where E is an object of $\tilde{\mathcal{F}}([X/G]_0) = \tilde{\mathcal{F}}(X)$ and ϕ is a collection of maps*

$$\phi^{k,1-k} \in \text{Hom}_{\tilde{\mathcal{F}}([X/G]_k)}^{1-k}(\tau_{k,0}^*(E), \rho_{k,0}^*(E)), \text{ for all } k \geq 1$$

which satisfy the following two conditions

1. the Maurer-Cartan equation

$$(-1)^k d(\phi^{k,1-k}) + \sum_{j=1}^{k-1} (-1)^j \partial_j^* (\phi^{k-1,2-k}) + \sum_{j=1}^{k-1} (-1)^{(1-j)(k-j)} \rho_{k,j}^* (\phi^{j,1-j}) \tau_{k,k-j}^* (\phi^{k-j,1-k+j}) = 0; \quad (24)$$

2. the non-degenerate condition: $\phi^{1,0}$ is invertible up to homotopy.

Moreover, a morphism θ of degree m from (E, ϕ) to (F, ψ) is given by a collection

$$\theta^{k,m-k} \in \text{Hom}_{\tilde{\mathcal{F}}([X/G]_k)}^{m-k}(\tau_{k,0}^*(E), \rho_{k,0}^*(F)) \text{ for all } k \geq 0$$

and the differential is given by

$$d\theta = D\theta + \phi \cdot \theta - (-1)^m \theta \cdot \psi$$

or more explicitly

$$(d\theta)^{k,m+1-k} = (-1)^k d_{\tilde{\mathcal{F}}(X_k)} \theta^{k,m-k} + \sum_{j=1}^{k-1} (-1)^j \partial_j^* \theta^{k-1,m+1-k} \\ + \sum_{l=1}^k (-1)^{(1-l)(k-l)} \rho_{k,l}^* \phi^{l,1-l} \tau_{k,k-l}^* \theta^{k-l,m-k+1} + \sum_{l=0}^{k-1} (-1)^{(m-l)(k-l)} \rho_{k,l}^* \theta^{l,m-l} \tau_{k,k-l}^* \psi^{k-l,1-k+l}.$$

Proof. It is a direct corollary of Theorem 2. \square

Remark 4.15. Proposition 6 tells us that for any X , the dg-functor $\tilde{\mathcal{F}}(X) \rightarrow \mathcal{F}(X)$ is quasi-essentially surjective and degreewise fully faithful. As a result in Proposition 12 we can replace E and ϕ by their image in \mathcal{F} and the result will not be infected.

For $k = 1$ Equation (24) is simply $d\phi^{1,0} = 0$, i.e. $\phi^{1,0} \in \text{Hom}_{\mathcal{F}([M/G]_1)}^0(\partial_0^*(E), \partial_1^*(E))$ is closed. For $k = 2$ Equation (24) becomes

$$d\phi^{2,-1} - \partial_1^* \phi^{1,0} + \rho_{2,1}^* \phi^{1,0} \tau_{2,1}^* \phi^{1,0} = 0,$$

which means that $\phi^{1,0}$ satisfies the cocycle condition *up to homotopy* and $\phi^{2,-1}$ gives the homotopy operator.

Now we need to verify that the cosimplicial diagram $\mathcal{F}([X/G]_\bullet)$ is Reedy fibrant so that the totalization is weakly equivalent to the homotopy limit.

Proposition 13. *If the G is discrete and \mathcal{F} sends finite coproducts to products, then the construction in Proposition 12 gives the homotopy limit of $\mathcal{F}([X/G]_\bullet)$.*

Proof. It is easy to see that in this case the simplicial space $[X/G]_\bullet$ is split and hence by Proposition 7 $\mathcal{F}([X/G]_\bullet)$ is Reedy fibrant and therefore the totalization and homotopy limit are weakly equivalent by Theorem 1. \square

This proposition hold for example if we consider $\mathcal{F} = \text{Cpx}$, the functor that sends X to the dg-category of complexes of sheaves of \mathcal{O}_X -modules on X .

We are left to consider the case when G is not discrete. In this case it seems that the diagram $\mathcal{F}([X/G]_\bullet)$ is no longer Reedy fibrant. (The matching maps are not levelwise surjective on hom-complexes in general.) We still expect the totalization and the homotopy limit to agree.

Conjecture 1. *If G is a reductive group scheme and $\mathcal{F} = \text{Cpx}$, then the construction in Proposition 12 still gives the homotopy limit of $\text{Cpx}([X/G]_\bullet)$.*
